1. The award will be known as the VMIA Professional Learning Award.
2. The award is to the value of \$10,000.00 and only open to current financial members of the BMV.
3. The award is intended to support an BMV member to engage in professional learning.
4. Applications for the award must be made on the pro-forma provided, and email: ATT: President of BMV to businessmanagersvictoria@gmail.com
5. Applications must be received by **4.00pm on Friday 31st March 2023**.
6. Applications will be considered by a panel, which will compromise:
 - The President of the BMV.
 - Two members of the BMV who are not applicants.
 - A representative from VMIA.
7. The role of the panel will be to evaluate all the applications and determine candidates for shortlisting.
8. If shortlisted, the applicant will be required to attend an interview (virtual).
9. Decisions rendered by the panel will be final and all information regarding applications will remain confidential.
10. The successful recipient of the award will be required to attend the presentation during the BMV Leadership Conference welcome dinner held the Pullman Albert Park on Wednesday 10th May 2023.
11. The Successful applicant will be required to have committed the award monies and acquit the spending by 30th June 2024.
12. The successful applicant may be required to speak at a BMV meeting regarding their experience with the scholarship.
